





Synopsis

Abigail wants to get back together with Ben. Ben refuses.

There appears to be a confrontation between Charlie, Abigail and Ben. Unfortunately, CCTV has not picked up the confrontation on video. The confrontation leads to Abigail falling over the rails and dying.

Adam, Ben's friend, sees the initial stages of the argument.

Utilising the CCTV and witness evidence, the CPS has decided to chare and prosecute. Ben is charged with Abigail's manslaughter (involuntarily.)

Statement to Police from Ben Jones – handed in after a 'no comment' interview.

I have been arrested on suspicion of killing my ex-girlfriend Abigail Mulliner at approximately 10.33 am on 28th June 2021.

On the morning of the 28th of June, I had discussed with Abigail that I was not interested in rekindling our relationship.

After she walked away, I saw, Charlie handing a bag to Abigail containing what looked like some pills. To be fair, she did not look 'with it' for a few weeks, and everything made sense. She had been very emotional and I was very firm with her that I did not want to enter into a relationship with her.

I went back across and took Abigail away from Charlie, and I explained this to Abigail and I explained to her that Charlie was a bad friend. I also told her (Abigail) that Charlie told me that they were in a relationship, and that was why I ended our relationship. She denied this and said the same was not true, and that they were just friends.

I also explained to her that Charlie was nothing but a street pharmacist, and clearly she was now giving drugs to her. I had no interest in being in a relationship with somebody that was always taking drugs.

I saw her go across to Charlie on the top floor at Senate House, and around the corner.

I went across to see what was going on, and Charlie and Abigail were arguing. Abagail was very close to the rails. The argument was heated and both Charlie and Abigail were crying. I stepped in to stop them and there was some pushing and shoving, and Abigail fell from the top floor.

I ran downstairs and called an ambulance.

I did not push, nor kill Abigail.

Witness Statement of Charlie Anthony

My name is Charlie Anthony, and I witnessed the killing of Abigail Mulliner at the hands of Ben Jones, at approximately 10.30 on 28 June 2021. I have known Abigail for 12 years. We grew up together.

On the morning in question, I met up with Abigail as usual downstairs in Senate House and we waited around for our class to start. The weather was sunny and everybody was in a good mood. Ben came over and asked to speak with Abigail. They went across the floor where I could see them having a conversation. The conversation appeared to be heated. Ben walked away, and Abigail came over back to me. She was very upset we talked about going out that night and letting our hair down. I told him to forget about him, she had me.

Next thing I knew, Ben had stormed across, grabbed Abigail's hand, and took her across the floor to where they had their first conversation. I could see that Abigail was visibly upset, and she walked away from him, and came back to me. She said that she needed to talk to me so we went around the corner for some privacy.

We discussed the fact that I had told Ben that myself and Abigail had had a relationship, and she wanted to know why I had done that. I explained to her that it was the truth and clearly we loved each other. Why else would she have kissed me?

At this point, Ben came across to us while we were having our private conversation. The conversation was about our love and our growing relationship, and I told him that he needs to let Abigail go as she doesn't need to him anymore.

Due to his jealousy and rage, he pushed Abigail, and she fell over the rail.

I tried to stop him, but he was too strong for me. He has also been violent towards her in the past, so clearly, he would do it again. I ran downstairs and I couldn't believe that she was not moving.

I don't know why he went across to her again. Shortly thereafter, Abigail walked away from Ben and went across to talk to her friend, that Charlie. Everybody knows she's a little weird. Abigail and Charlie then went around the corner. Ben followed shortly after. There was some arguing and shouting going on, before there was a scream. I don't see how Ben could have possibly pushed Abigail on purpose. It's a mistake and Ben would not so that.

Ben

I wanted to apologise. I didn't push her!

Charlie

Oh yeah. Cos' you fix everything with an apology.

Ben

What's that supposed to mean?

Charlie

Finally getting your own back were you? It was only a matter of time before you hit back.

Ben

I didn't touch her! That only ever happened once!

Charlie

You've got a temper and we all know it. You've had it in for her for months!
