

Jenkinson Prizes 2019

1. The 2019 Jenkinson Prizes are designed to recognise and celebrate exceptional achievement in three areas of research – publication, teamwork and early career development. These Prizes complement the Jenkinson Awards which focus on specific projects which support research excellence and the student experience.
2. The criteria are specified in Table I (below). It is recognised that publications, teams and ECRs vary significantly across disciplines and that excellent achievement is often distinctive. In that context, applicants should feel free to interpret the criteria and what is relevant evidence in a manner that is appropriate for their subject area and research work. All submission must demonstrate how their work has and/or will improve the student experience. Different submissions are likely to address this in different ways. The criteria will be applied holistically in order to ensure all submissions are assessed appropriately. Applicants will need to ensure they address the relevant criteria in the Supporting Statement section of the online application form.
3. All University of Bolton staff including fractional and short-term staff are eligible to be nominated. Students, including research students are not eligible (unless also staff).
4. No appendices or documentary evidence should be submitted with the application form. Applicants submitting nominations for the Publication of the Year will be advised following submission on the arrangements for making a copy of the publication available to the Panel.
5. The Panel reserves the right to request evidence or further information from applicants following submission of nominations.
6. Nominations can be made for oneself or on behalf of others. In the event that a nomination is made for someone other than the person making the submission, the permission of the nominee will be sought by the Panel prior to the publication of the shortlists.
7. An individual can make nominations (of self or others) to all three of the categories and can in principle win more than one prize.
8. Having secured a Jenkinson 2019 Award is neither a bar nor a qualifying criterion for applying for a Jenkinson Prize.
9. The Prizes include a certificate and financial support for an appropriate staff development activity. The expenditure for this activity must occur by 31 July 2019.
10. A shortlist will be announced for each category in November with the winners announced at the Jenkinson 2019 Awards Ceremony on Thursday 13 December 2018
