The vibrant School of Law offers courses in both law and criminal justice. Our excellent facilities provide the right environment for our students to learn, including a courtroom, a Legal Advice Centre, an independent law library for students and the support of an eminent line-up of academic and external professors, including practising solicitors, barristers and judges.

Excellent links with local employers are equally complemented by our student support scheme, through personal tutors, student liaison officers, peer mentors and our central student services.

Our LL.B (Hons) Law course will provide you with the professional competencies of functioning legal knowledge and applied skills as required for the Solicitor's Qualifying Examination (overseen by the

Solicitors Regulation Authority) to become a solicitor in England and Wales. It also satisfies the Academic Stage of training to become a barrister in accordance with the Bar Standards Board and allows you to proceed to the vocational stage of training.

Our Centre for Contemporary Coronial Law, launched in 2016, is now approaching its 4th year. In addition, The University of Bolton's Legal Advice Centre launched in September 2019, where Law students are guaranteed a work placement and can put their acquired skills into practice by assisting members of the public with their legal enquiries.

Finally, our crime and criminal justice course is recognised by leading crime and victim agencies.

The criminal justice sector offers a wide range of rewarding and challenging careers. We work in collaboration with criminal justice partners including Her Majesty's Prison and Probation Service, the Home Office, Police Services & UK Border Force, whose role is to investigate, collate intelligence, enforce compliance of British legislation and manage offenders.

The course allows you to **learn and explore** different types of law, and be assessed in a variety of ways.

On the criminal justice course you will embrace critical thinking to investigate individual, social, legal and political forces that shape crime and how it is controlled. Theory is supported by practice in crime causation, criminal behaviours and how to combat crime.


You will be encouraged to develop skills such as critical reasoning, analytical ability, problem solving, theoretical and conceptual thought and the application of theory to real situations.

Academics with criminal justice backgrounds encourage you to develop practical skills, including the personal qualities of resilience and determination, needed to work in this dynamic sector.
